For the right to participate in the activities and events of the Oswego County ATV Club, and for being permitted to operate off highway recreational vehicles on designated trails and areas located on property of Landowners, whose permission has been obtained by the Club for riding during the Club's open season (3<sup>rd</sup> Sat. in April conditions permitting through Sep 30th). I understand and acknowledge the risk of accident or injury to my person or property and to others while riding ORV's. I accept and assume all risks, dangers, and responsibilities for any such accident or injury no matter how, or by whom, it may be caused. To the fullest extent permissible by law, I hereby release, waive, discharge and covenant not to sue the Club or any Landowners for any liability, and further agree to indemnify and hold them harmless for accident or injury whether caused by the negligence of the Club or the Landowners, or otherwise. It is State Law and your responsibility to wear a helmet, have your machine registered and insured, and be able to prove it. Federal, State and Local Codes, Regulations and Laws must be obeyed at all times. BY SIGNING THIS AGREEMENT, I AGREE TO FOLLOW ALL CLUB, STATE & LOCAL LAWS

**All members operating an All Terrain Vehicle on the Trail System MUST OBEY all NYS Laws for All Terrain Vehicle Use, and all Club Rules and Code of Ethics. Failure to do so MAY/WILL result in termination or suspension of membership without a refund. Members are also subject to ANY Law Enforcement action by any NYS Law Enforcement Officer. The ATV Club will not be held responsible for any legal actions persons receive from Law Enforcement or Court Depositions.**

***“CLUB RULES AND CODE OF ETHICS”***

- 1) Current club stickers are to be placed on the front left side of all machines.*
- 2) I will SLOW DOWN, USE CAUTION, and be courteous of other riders, and persons either, on the trail system or including business access areas such as parking lots. I will safely Yield to any lane approaching vehicle traffic, allowing them to pass safely.*
- 3) I will ride only on designated trails and areas and will not bypass our bridges and stream crossings by going up and down streams.*
- 4) I will respect and preserve the public and private property that I ride on. I will not go around wet holes and make them bigger as it causes more work and expense. If you do not want your machine to get muddy then it is best to keep it in the garage.*
- 5) I will make sure my equipment meets NYS Safety requirements, Insurance, NYS Registration requirements, A Noise limit of 82db. No Loud Speaker's shall be used while riding on the Trail System.*
- 6) I will NOT Endanger myself or other trail users by riding beyond my ability or while impaired by Alcohol or Drugs. No Alcohol or Drugs allowed on the Trail System. It is my duty as a club member to report any other rider that IS NOT obeying the Clubs Rules or State Laws.*
- 7) I will not construct jumps or obstacles anywhere on the trails or riding areas. It is my duty to help keep our trails clean and safe. If you see debris on our trail, such as cans, bottles, cigarette packs, etc., pick them up. Report any unsafe conditions to the Board or line officers, such as beaver dams, flooding, wash outs, fallen trees, etc.*
- 8) Eliminate and Changed to: I will attempt to make Work Details or Fund Raisers. I will not leave litter or debris on the Trail System, and I will pickup any litter I see on the Trails.*
- 9) I WILL obey the speed limit of 25mph on all trails and roadways designated for All Terrain Vehicle use unless otherwise posted as such.*
- 10) I WILL WEAR a DOT approved helmet at ALL times whether operating or as a passenger of ANY All Terrain Vehicle. NO EXCEPTIONS!*
- 11) Whenever operating a All Terrain Vehicle on the Trail System the headlights MUST be ON.*
